<p>** Uniform Commercial Code should be 2012 or newer. The Selected Commercial Statutes published by West is probably the best. Older editions are available very inexpensively online. Note that it is published in four versions: 1) Selected Commercial Statutes; 2) Selected Commercial Statutes for Sales and Contracts Classes; 3) Selected Commercial Statutes for Payment Systems Courses; and 4) Selected Commercial Statutes for Secured Transactions Courses. All four versions include the entire UCC which is the main thing you will need. However, the versions differ in the additional materials they include. The first one, the just plain Selected Commercial Statutes, is probably the best one to get if you are buying one because it includes all the materials needed for any of the commercial courses. The others include only what is needed for the particular courses. As a result they are a little smaller and easier to carry You can get by with any version of the UCC as long as it has the complete text of the comments.
